Description of Modification

The purpose of this modification is to close out the subrecipient agreement; specifically to:

1. Decrease the obligated amount from BDT 13,156,958.00 to BDT 13,156,422.00. This is based on the final expenditure outlined in the final financial report submitted by PARITRAN.
2. Reduce the agreement budget from BDT 13,156,958.00 to BDT 13,156,422.00.

Accordingly, the Associated Sub recipient Agreement is hereby modified as follows:

Delete in its entirety Section C. 1 "Amount of Agreement and Payment" and insert in its place:

C. AMOUNT OF AGREEMENT AND PAYMENT

1. The total estimated amount for the period shown in Section B above is BDT 13,156,422.00. Plan Bangladesh hereby obligates the amount of BDT 13,156,422.00 for the period set forth in Section B above for performance of this Agreement in accordance with the budget as detailed in Attachment F (PHR Program Small Grants Budget, subject to the availability of funds). Plan Bangladesh is not obligated to reimburse the Sub-recipient for the expenditure of amounts in excess of the total obligated amount. Sub-recipient will submit the requests for advance based on a cash flow projection to Plan Bangladesh, to attention to Chief of Party (COP-PHR). Plan Bangladesh will make advances for ninety (90) days and Sub-recipient will report and reconcile the advances with the monthly financial reports.

Plan Bangladesh will make advances by wire transfer to the Sub-recipient's designated bank account as below:

Account Title: PARITRAN-PHR.

Bank name & address: Social Islami Bank Ltd. Monirampur Branch, Uttar Matha Bus Stand, Jessore.

Sub recipient must justify 85% of advance received before requesting another advance. Plan Bangladesh will not give/provide Sub-recipient any other advance before/until 85% of the previous advance has been justified and justification approved by Plan Bangladesh.

Delete in its entirety Section D "Agreement Budget" and insert in its place:

D. AGREEMENT BUDGET

The following is the agreement budget, including local cost financing items, if authorized. The Sub-recipient is required to report deviations from the budget and program plans and request prior approval from the Plan Bangladesh in accordance with the Mandatory Standard Provision "Amendment of Award Budget and Revision of Budget (August 2013)" (Attachment C).
